- is able to implement crop husbandry and crop farming
- is able to use various techniques of the production of horticultural products (garden farming, fruit gardening, production of ornamental plants, seed growing)
- knows technological machinery and equipment
- is able to designate objects on a plan at a basic level and to map them on a plan
- knows the varieties of greenhouses and storage facilities

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE <sup>(1)</sup>

A holder of the Gardener II professional qualification certificate is employed in gardens, planted areas, gardening farms, cemeteries, nurseries, as horticultural caregivers in greenhouses and in other fields of the floral trade.
