A holder of the Chimney Sweeper level I professional certificate:

- verifies the fire safety of heating and ventilation systems
- cleans heating and ventilation systems
- cleans ranges, heat walls, stoves, chimneys and the outlets and smoke flues of gas equipment
- informs the population of the correct use of heating systems
- reports any discovered faults in the heating and ventilation systems
- evaluates the existing heating systems and makes relevant recommendations
- ensures fire safety, economic heating routines and clean living environment
- is familiar with the legislation pertaining to the work of the Chimney Sweeper, particularly fire and occupational safety and construction
- is familiar with the safety requirements for the installation of heating and ventilation equipment
- is familiar with the building materials used in chimneys and heating equipment
- is able to use and adjust the technical equipment and tools used for the cleaning of ventilation systems and chimneys and for the assessment of safety

The Fire Safety Association was founded in 1919 and it operates in the current form since April 1991.
